### COVID-19 Liability Release Waiver

*The World Health Organization has declared the Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the government has set recommendations, guidelines, and some prohibitions which PCLA/Paragon Academy adheres to comply.*

- In consideration of my participation with PCLA/Paragon Academy, the undersigned acknowledge and agree to the following:

I am aware of the existence of the risk to myself and my family in attending classes and activities associated with and at PCLA/PA that may cause injury or illness such as, but not limited to Influenza, MRSA, or COVID-19.

I have not experienced symptoms of fever, fatigue, difficulty in breathing, or dry cough or exhibiting any other symptoms relating to COVID-19 or any communicable disease within the last 14 days and agree to immediately let PCLA office staff know if those symptoms change and agree to self-quarantine myself and/or my child for a minimum of 14 days if those symptoms become present.

I have not been, nor any member(s) of my household, diagnosed to be infected of COVID-19 virus within the last 30 days and agree to immediately let PCLA office staff know if this status changes and agree to self-quarantine myself and my child for a minimum of 14 days if any member of my household is directly exposed or diagnosed with the COVID-19 virus.

- Following the pronouncements above I hereby declare the following:

I am/my children are fully and personally responsible for my own safety and actions while and during my participation at PCLA/PA and I recognize that I may be at risk of contracting COVID-19. With full knowledge of the risks involved, I hereby release, waive, discharge PCLA and Paragon Academy, its board, officers, independent contractors, affiliates, employees, representatives, and successors from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me or my household related to COVID-19 while participating in any activity while in, on, or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19. I agree to indemnify, defend, and hold harmless PCLA and Paragon Academy from and against any and all costs, expenses, damages, lawsuits, and/or liabilities or claims arising whether directly or indirectly from or related to any and all claims made by or against any of the released party due to injury, loss, or death from or related to COVID-19.

- By signing below I acknowledge that I have read the Liability Release Waiver and understand its contents; that I am at least eighteen (18) years old and fully competent to give my consent and/or am signing in consent of my legal minor. I have been sufficiently informed of the risks involved and give my voluntary consent in signing it as my own free act and deed.
